- 1. Call to order: 6:05PM

- 3. **Opening prayer:** Greg provided the opening prayer.
- 4. **Introduction of guests, if any:** Rebecca is interested in Affordable Housing and represents the Community Land Trust. She is interested in exploring options for her organization to work with Highland Lakes Habitat for Humanity.
- 5. **Approval and or correction of minutes:** Approved. 8 ayes, 0 nays. October board meeting was cancelled due to board member conflicts.

Tommy to contact the partner furthest behind on payments. Board approved initiating foreclosure of this property.

Closing on 804 Sherwood Downs to be completed 11/13/2023.

Carol to handle closing for 800 Sherwood Downs. The board approved exploring Habitat Texas Habitat as an option.

Cadence Bank approved signers will be completed by 11/15/2023.

Board approved "Shared Appreciation" for future mortgages.

 - b. Good Standing Status Reinstatement to Good Standing with Habitat International is pending IRS processing of tax returns and reinstatement of 501C3 status. Required tax filings and 1023 have been received by the IRS in May; current processing time is 6 months. Tax return for 2022 is underway by our accountants. - Harry Born
